2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: Contains a plasticised water based acrylic emulsion with dense fillers, very minor amounts of white spirits (ca. 1%), dispersants, boric acids, and acrylic associate thickeners.

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.
